ABSTRACT AND FINAL PAPER

The full paper should be submitted in English language and it should fulfill the following criteria: Page format A4, Font Times New Roman 12, space 1, margins 2.5 cm. The title of the paper should be aligned in the center, using capital and bold letters. Any paper exceeding 6000 words, including references, footnotes and bibliographies, will not be accepted.
