International Labour Law

International labour law is the judicial disciplinary which studies the body of legal rules that apply between **sovereign states and such other entities as have been granted international personality by sovereign states**. Concerning labour law, the most important entity is International Labour Organization. International labour standards can serve as a general guide and as a source of inspiration to governments by virtue of their authority as texts adopted by an assembly composed of representatives of governments, employers and workers of nearly all countries of the world. They may also for that reason provide a basis for the claims of workers and guide the policy of employers. International labour standards have thus developed into a kind of "international common law". Those in charge of social policies in various countries have often highlighted this role of international labour law.
